






February 2020 Project Activity Report

The EDC received 10 new RFIs (requests for information) in March and submitted sites/buildings for all 10 of the new requests. There were 4 client/ consultant site visits in March.



The EDC received 2 new RFIs (requests for information) in July and submitted sites/buildings for both of the new requests. There were 3 client/ consultant in-person visits in July.



The EDC received 5 new RFIs (requests for information) in September and submitted sites/buildings for 4 of the new requests. There was 1 client/consultant in-person visit in September.



The EDC received 10 new RFIs (requests for information) in November and submitted sites/buildings for 8 of the new requests. There were no client/consultant visits in November.




